



TILES FOR STYLE LICENSE AGREEMENT

IMPORTANT NOTICE: PLEASE READ THIS AGREEMENT CAREFULLY BEFORE PURCHASING AND USING ANY DESIGN FROM TILES FOR STYLE. BY PLACING AN ORDER ON TILESFORSTYLE.COM, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT.

1. Definition

- **“Design”**: Refers to any print, pattern, or graphic, including all associated metadata, keywords, descriptions, and captions, purchased from TilesForStyle.com.
- **“Commercial License”**: A license automatically granted with each design purchase, allowing for the creation and sale of unlimited end products incorporating the Design.
- **“Licensed Design”**: The specific Design that is licensed to you under this agreement.
- **“License Fee”**: The fee paid for the purchase of a Design, which includes the Commercial License.
- **“Intellectual Property Rights”**: All rights related to the Design, including copyrights, design rights, trademarks, and other related rights.
- **“Usage Guidelines”**: The rules governing how you can use the Licensed Design.
- **“Website”**: Refers to tilesforstyle.com.

2. Grant of License

2.1 **Commercial License**: Upon payment of the License Fee, Tiles For Style grants you a non-exclusive, worldwide Commercial License to use the Licensed Design. This includes the right to create and sell unlimited physical products incorporating the Licensed Design, including but not limited to clothing, homeware, stationery, accessories, posters, and postcards.

2.2 **Usage Scope**: The Commercial License permits you to use the Licensed Design in any physical product for sale, with no limit on production runs. The license is valid for the lifetime of the copyright on the Licensed Design.

2.3 **Prohibited Uses**: You may not duplicate, sub-license, resell, or redistribute the Licensed Design as a standalone file. The Design may not be used in any material that is pornographic, fraudulent, obscene, immoral, infringing, illegal, blasphemous, or defamatory.

3. Intellectual Property Rights

3.1 **Ownership**: All Intellectual Property Rights in the Licensed Design remain the exclusive property of Tiles For Style. Your purchase and use of the Design do not transfer any ownership of these rights.

3.2 **Infringement**: You must notify Tiles For Style immediately if you become aware of any actual, suspected, or threatened infringement of the Intellectual Property Rights in the Licensed Design.

4. Payment and Delivery

4.1 **License Fee**: The License Fee for the Design is as displayed on the Website at the time of purchase. This fee includes the Commercial License.

4.2 **Payment**: The License Fee must be paid in full at the time of purchase. Once payment is confirmed, the Licensed Design will be made available for download.

5. Warranties and Indemnities

5.1 **Tiles For Style's Warranties**: Tiles For Style warrants that it has the authority to grant this license and that the Licensed Design does not infringe on the rights of any third party to the best of its knowledge.

5.2 **Your Warranties**: You warrant that you will not use the Licensed Design in any way that could harm Tiles For Style's reputation or business and that your use of the Design will comply with all applicable laws.

5.3 **Indemnity**: You agree to indemnify Tiles For Style against all liabilities, costs, expenses, damages, and losses arising out of or in connection with your breach of this agreement.

6. Limitation of Liability

6.1 **No Warranty of Suitability**: The Licensed Design is provided “as is” without any warranty that it will meet your specific requirements. Tiles For Style is not liable for any issues arising from your use of the Design.

6.2 **Maximum Liability**: Tiles For Style's total liability under this agreement is limited to the amount of the License Fee.

7. Termination

7.1 **Termination for Breach**: This agreement may be terminated immediately if you breach any of its terms. Upon termination, all rights granted to you under this agreement will cease.

8. Miscellaneous

8.1 **Assignment**: Tiles For Style may assign or transfer its rights under this agreement. You may not assign or sub-license your rights under this agreement without prior written consent.

8.2 **Entire Agreement**: This agreement, together with the license terms on the Website, constitutes the entire agreement between you and Tiles For Style regarding the Licensed Design.

8.3 **Severability**: If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions will remain in full force and effect.
